NOW THEREFORE, BE IT RESOLVED that the Board of Fire Commissioners of the South Hempstead Fire District has adopted a proposed Annual Fire District Budget for 2026 as of this date for purposes of discussion and review at the Budget Hearing to be held on October 21, 2025 and a copy of the proposed budget is available at the office of the Town Clerk of the Town of Hempstead and at the office of the South Hempstead Fire District Secretary at 555 May Street, South Hempstead, New York where it may be inspected by any interested person during office hours. In addition, a copy of the proposed budget is posted on the fire district's website, and copies of the proposed budget will be available on the night of the said hearing.

NOW, THEREFORE BE IT FURTHER RESOLVED that the Board of Fire Commissioners of the South Hempstead Fire District will hold the Annual Fire District Budget Hearing to be conducted with reference to the Annual Fire District Budget for fiscal year 2026 on Tuesday October 21, 2025 commencing at 6P.M. at the Fire Headquarters Building located at 555 May Street, South Hempstead, New York.
